The project consists of the replacement of concrete steps, metal railing and aluminum storefront at the Administration Offices Entrance located at 1 Tranquility Base, Huntsville, Alabama 35805. The work includes demolition to the concrete steps inside the existing to remain concrete cheek walls per drawings. There will be limited metal railing removed to allow for new compliant metal railings per drawings. The aluminum storefront system including a single door and fixed glass will be removed and replaced with a double door with fixed glass.

A cashier's check or bid bond payable to Alabama Space Science Exhibit Commission in an amount not less than five (5) percent of the amount of the bid, but in no event more than \$10,000, must accompany the bidder's proposal in the amount of \$100,000 or More. Performance and Payment Bonds, evidence of insurance required in the bid documents, and Builders Risk will be required at the signing of the Contract.

Drawings and specifications may be examined at the office of McMillan Pazdan Smith Architecture, 100 Church Street, Suite 700, Huntsville, AL 35801.

General Contractors may obtain PDF formatted Bid Documents from the Architect.

Bids must be submitted on proposal forms furnished by the Architect or copies thereof. All bidders bidding in amounts exceeding that established by the State Licensing Board for General Contractors must be licensed under the provisions of Title 34, Chapter 8, Code of Alabama, 1975, and must show evidence of license before bidding or bid will not be received or considered by the Architect; the bidder shall show such evidence by clearly displaying his or her current license number on the outside of the sealed envelope in which the proposal is delivered. The Owner reserves the right to reject any or all proposals and to waive technical errors if, in the Owner's judgement, the best interests of the Owner will thereby be promoted.
