The USSRC A12 Exhibit project will include (3) structural foundations and (3) steel columns for the plane to mount at the requested position. There is limited concrete and landscape demolition. It will have limited concrete flatwork, landscape rock, lighting, a flagpole & lightning protection. This is an exterior exhibit with no conditioned space.

A cashier's check or bid bond payable to Alabama Space Science Exhibit Commission in an amount not less than five (5) percent of the amount of the bid, but in no event more than \$10,000, must accompany the bidder's proposal in the amount of \$100,000 or More. Performance and Payment Bonds, evidence of insurance required in the bid documents, and Builders Risk will be required at the signing of the Contract.

General Contractors may obtain PDF formatted Bid Documents from the Architect.

Bids must be submitted on proposal forms furnished by the Architect or copies thereof. All bidders bidding in amounts exceeding that established by the State Licensing Board for General Contractors must be licensed under the provisions of Title 34, Chapter 8, Code of Alabama, 1975, and must show evidence of license before bidding or bid will not be received or considered by the Architect; the bidder shall show such evidence by clearly displaying his or her current license number on the outside of the sealed envelope in which the proposal is delivered. The Owner reserves the right to reject any or all proposals and to waive technical errors if, in the Owner's judgement, the best interests of the Owner will thereby be promoted.
