NOTICE: THIS IS A RE-BID - SEALED BID PROPOSALS will be received from licensed General Contractors by Hoover City Schools, at the **Hoover City Schools Operations Building**, 1070 Buccaneer Drive, Hoover, AL 35245, until 2:00PM Local Time, WEDNESDAY, April 29, 2026 for the **HOOVER HIGH SCHOOL LOBBY RENOVATION – RE-BID** at which time and place they will be publicly opened and read aloud. General Contractor's License Number and Type must be on the outside of the bid envelope. Bids submitted without the GC license number on outside of the envelope will not be accepted.

A cashier's check or bid bond payable to Hoover City Schools in an amount not less than five (5) percent of the amount of the bid, but in no event more than \$10,000, must accompany the bidder's proposal. Performance and Payment Bonds and evidence of insurance required in the Bid Documents will be required at the signing of the Contract.
