Alabama Public Television Madison Avenue Studios Lighting Replacement. Work includes both Broadcast Studio lighting and ambient “work” lighting. Scope consists of replacement of existing lighting fixtures (both studio and ambient). New studio lighting system includes fixtures, controls, retrofitting the existing dimmer rack with on-off modules, and associated accessories and cabling for a complete system. Ambient work lighting includes 16 LED wraparound lights to replace existing fluorescent.
